<u>Summary</u>

For Council to accept a tender from Moore Construction (WA) Pty. Ltd. in respect of "Tender RFT 02/2015-16, being Construction of the Boddington Recreation Centre".

<u>Background</u>

Andrew Casella, Procurement Consultant with Western Australia Local Government Association (WALGA), was engaged in November 2015 to assist in the preparation of the Procurement Plan for the design and construction (D&C) of the new Recreation Centre.

WALGA was further engaged to undertake the tender process through "Tenderlink"

Public tenders were called by WALGA on 5 December 2015 with a closing date of 20 January 2016. WALGA arranged a site meeting for 10 December 2015 for prospective tenderers where it was established and agreed that the closing date was too short and likely result in few tenders. The closing date was subsequently advertised to be 19 February 2016.

Comment

Ten tenders were received by the closing time and there were no late submissions.

Attachment 3.1.1A is a confidential report prepared by WALGA following each criteria of the tenderer being individually assessed by the three panel members.

The Evaluation Panel unanimously recommends awarding the contract to Moore Construction (WA) Pty. Ltd., subject to WALGA undertaking referee checks and a credit assessment report.

Strategic Implications

Significance in that it will provide a purpose-built sports and recreation facility under cover.

Statutory Environment

Local Government Act sec. 3.57;

Policy Implications

Council Policy 13.1 Buy Local Policy (Regional Business and Regional Price Preference).

<u>Financial Implications</u>

The scope of works advertised in the tender detail all known requirements. However, it is considered prudent to allow a contingency of 10% of the tendered price.

The Officer Recommendation is to accept a tender for a price of \$3,520,100 excluding GST.

It is recommended that a contingency of 10% be allowed in addition to the tendered price, to cover any unknown factors.

The expenditure of the contingency would only occur with the prior approval of the Chief Executive Officer. On this basis, the project budget would be \$3,872,110 (excluding GST).

The 2015/16 adopted Council budget includes funding of \$4.6m for the project, which was based on funding available to Council when the budget was set.

No allowance was made in the tender documentation for car parking, landscaping and disabled access on the advice of the Architects that the \$4.6m budget was likely to only cover the building costs.

Any savings from the tender process would need to be applied to these elements to complete the project.

<u>Economic Implications</u> – Nil at this planning stage.

Social Implications

The commencement of this project will add to the community's social fabric, as it has been delayed for considerable time.

<u>Environmental Considerations</u> – Nil known at this stage.
